SDGs


- New set of global development goals to guide development (2015-2030)
- For economic development, social equity and environmental sustainability
- Compared to the MDGs, the SDGs will be integrated, universally applicable and transformative


ASEAN EC

- Integration to officially begin in 2015;
- 3 pillars of ASEAN Community: Economic Community, Political and Security Community, Socio-cultural Community
- ASEAN to "ensure sustainable development for the benefit of present and future generations and to place the well-being, livelihood and welfare of the peoples at the centre of the ASEAN community building process" (ASEAN charter 2008)

Links between ASEAN EC and the future SDGs:

- \checkmark Convergence between the objectives of SD and that of ASEAN's mandate
- ✓ Time overlap (both SDGs and the ASEAN Community will start in 2015)
- \checkmark ASEAN already incorporated the MDGs into their main strategies for Regional Integration
- It seems logical that ASEAN should take into account SDGs and 3 dimensions of sustainable development in their RI process as well

- Ensure access to affordable, reliable, sustainable, and modern energy for all
- Reduce inequality within and among countries
- Ensure availability and sustainable management of water and sanitation for all

Compared to the MDGs the SDGs are more complex and must deal with cross-sectoral effect between pursuit of different goals

Recommendations

- ASEAN incorporated MDGs (former development goals) into their strategic documents (2009)
- ASEAN Community and SDGs both have 2015 as starting date
 - Many environmental impacts are expected from increased regional economic and social integration in ASEAN (transboundary/trans-national solutions.
 - ASEAN could prioritize SDGs as part of their integration post 2015
 - Use existing institutional framework (EC, PSC, SCC) but make greater effort at institutional coordination
 - For example expand the two track approach T1/T2 to plan and implement for future goals and targets (both RI and SDG related goals)
