#### **Vulnerability to Climate Change**

Fiji's high land-area to coastline ratio and coastal concentration of human settlements, infrastructure, and livelihoods makes the nation highly exposed to sea level rise and coastal inundation

Climate change as a threat to 'ontological security' – it threatens the very nature of being' and identity in vulnerable Fijians

Climate Change Impacts – threatens food security and livelihood options for coastal dwellers

#### Challenges

- Community relocation can be met with resistance due to cultural and social ties to land
- Difficulties in ensuring proper compensation and support for displaced communities
- Consideration of the psychological and social impacts of relocation remains unclear
- Failure to recognize or account for the significant variance involved with the context-specific needs, views, and dynamics within and between communities
- Sustainable financial mechanism

### Measures Taken by Fiji Government

- Lessons learned from relocated communities have prompted the Fiji government to acknowledge the importance of planned relocation as a last resort.
- The <u>Standard Operating Procedures</u> (SOP) for planned relocation in Fiji serves to support the successful operationalization of the <u>Planned Relocation</u> <u>Guidelines (PRG)</u>
- Climate Change Act "The Minister, with the assistance of the Fijian Taskforce on Relocation and Displacement, must operationalize the Fijian Planned Relocation Guidelines through developing standard operating procedures which enable pro-active processes for addressing the risk of climate and disaster driven displacement"

## **Priority Areas**

- Post-relocation monitoring and consultation to identify any long-term issues for relocated or host communities
- Securing adequate funding and resources to support climate adaptation initiatives and displacement prevention strategies.
- Post relocation studies to update NAP and PRG
- Income Diversification Strategies

#### Conclusion

- Climate change impacts and the current and future local implications of these impacts now threaten long-established social narratives and value systems in the Pacific
- Community characteristics, circumstances, perceptions, understanding, histories, preferences, and social narratives are likely to play a more significant role in the conceptualization of risk and approaches to mobility issues than stepwise procedures, assessments, and policies
- More frequent community wide consultations to better understand community dynamics and adaptation strategies
- NAP must focus on strategies for income diversification
